## A Message from the President of the Board

### Mary Ellen Brown



*Mary Ellen Brown has served as board president since January 2012.*

2012 was a good year at MCUM for me: I had the opportunity of learning about the intricacies of running childcare, of negotiating all of the government regulations, of the financial bottom line, not only for childcare but for emergency services. I attended almost all committee meetings to learn what the tasks were as well as the importance of having involved participants. I observed the dedication of the staff and their willingness to go above and beyond the call of duty. And I felt how lucky Bloomington was that almost seventy-five years ago, a group of church women

decided to found what has become MCUM.

Yet 2012 was not a totally a good year for MCUM as a whole: budgetary shortfalls meant that programs had to be cut (summer camp) and curtailed (the Puffin Room). The Childcare Program now opens half an hour later and morning snack is no longer served. It is hard to contract, to go backwards, even in response to fiscal constraints. Yet those who were served by MCUM continued to receive quality support; children were provided for. And the core mission of MCUM remained strong—assisting with emergency needs and subsidized childcare.

One of the most ambitious projects of 2012 was the development of a strategic plan for the next five years, a plan which will bring MCUM into direct dialogue with other social service agencies in Bloomington and will strengthen the core programs—funding the Puffin Room and introducing fresh foods to emergency services, hiring a coordinator for volunteer services and increasing the already amazing number of volunteers from 250 to 500! To do these and a number of other things, we will need to increase our financial resources through individual and corporate contributions as well as established programs like “Each One, Feed One” which generates many participants and much food. And in all of these enterprises, we need to make MCUM known to all residents of Bloomington so that together we can ensure that those needing help and support will receive it.

Supporters of Monroe County United Ministries believe that quality early childhood education should be accessible to all, regardless of income. MCUM is one of only eight childcare centers accredited by the National Association for the Education of Young Children in Monroe County, and the *only* center whose mission is to serve low-income families. We believe our investment in young children will benefit not only our young neighbors but our community as a whole. Studies show literacy-rich care improves a child's chances of later success in school and in life. Benefits are seen in improved graduation rates, higher earning potential, reduced incarceration rates, and higher rates of civic participation. This is what your contributions to MCUM -- time, energy, and money -- have supported.

### Affordable Childcare

In 2012, 124 preschool children benefited from MCUM's licensed and accredited Childcare Program. These children developed literacy skills, mastered science concepts, learned English as a second language, explored interpersonal relationships, investigated the natural world, developed motor skills, and much more during their time in this program.

In addition to providing care for children, this program strives to provide comprehensive services for families. In 2012, these included flu shots and lead screenings, dental cleanings, Christmas assistance for interested families, and referrals to other services in the community.

But let us not forget the impact your support has on our enrolled preschoolers' parents. Parents and guardians were able to maintain steady employment knowing that their children's care was safe and reliable. They received support in guiding their children's education and preparing them for life after MCUM. It was a successful year for our program, simply because childcare families had remarkable support from our community.

With two caseworkers and meaningful community support, Monroe County United Ministries' Emergency Services Program provides basic needs assistance to people in financial crisis. A crisis may be brought on by unemployment, illness, injury, or an unexpected expense, but regardless of the cause, we work to help people through difficult times. Sadly, difficult times continue unabated for many in our community.

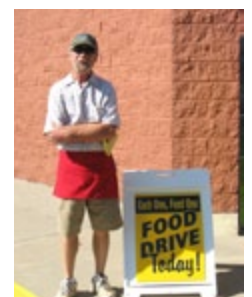
In 2012, this program provided essential assistance to 971 local families, 34% had never sought help from MCUM before.

### Emergency Services

These families were provided with assistance, engaged in finding solutions to their challenges, and supported in their return to self-sufficiency.

This program is made possible through the donation of food, cleaning supplies, hygiene items, clothing, and household items to MCUM and Opportunity House. In 2012, the Emergency Food Pantry received 72,371 pounds of donated items. We appreciate the support the pantry receives from individuals, congregations, clubs, schools, and businesses.

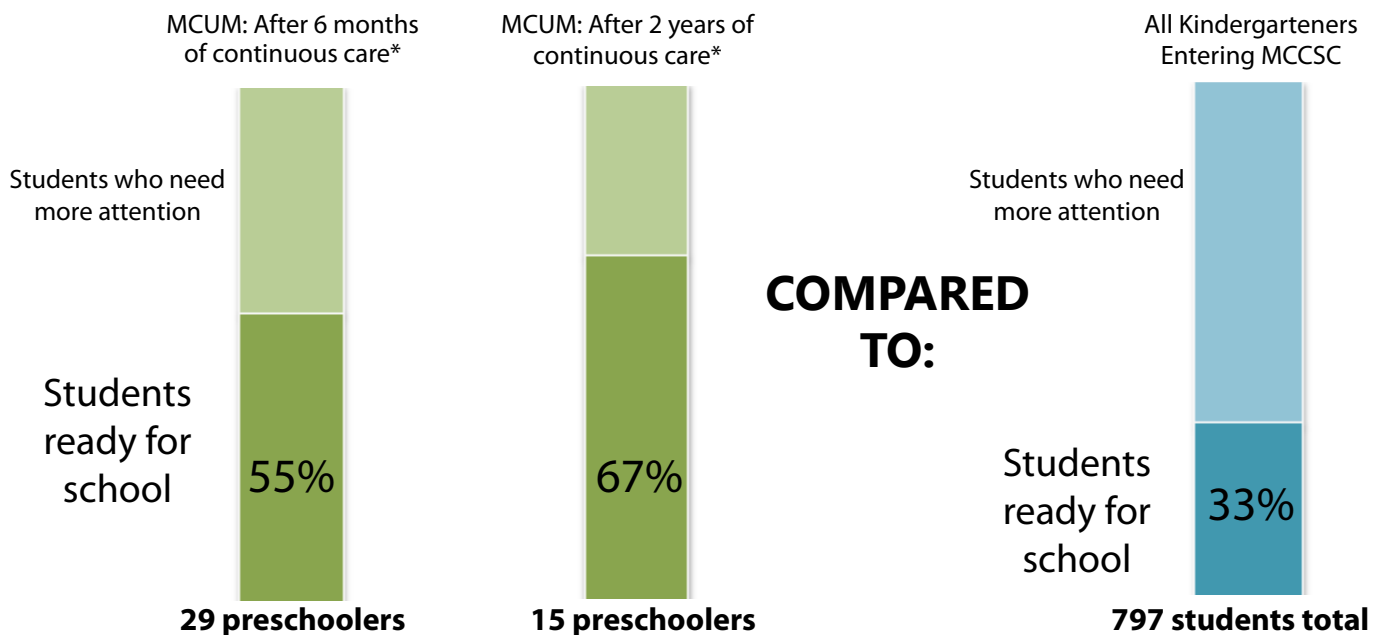

## School Readiness of MCUM Preschoolers, 2012

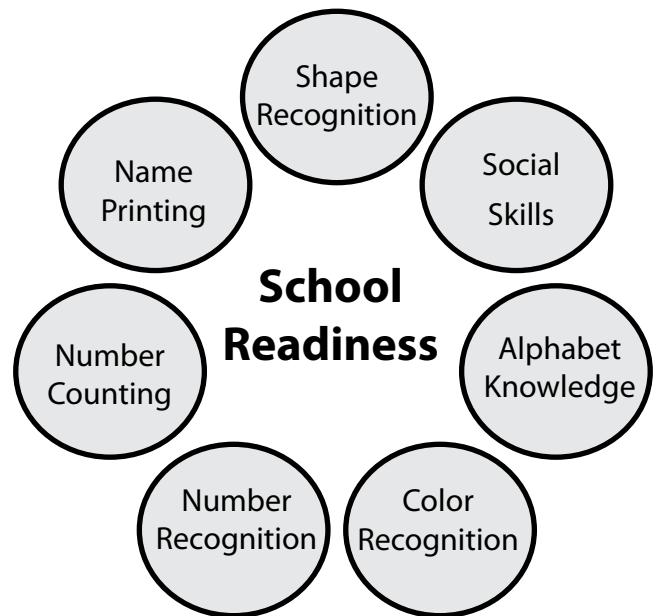


\* We did not provide numbers on every child enrolled with MCUM who would be ready for kindergarten or first grade because many had not been enrolled for enough time to attribute any performance to MCUM's program.

### Seven key areas are essential for success in kindergarten or first grade:

### How do we measure school readiness?

Children enrolled in MCUM's Childcare Program are assessed at least twice each year, more often if deficiencies are identified. The results of the Ages & Stages Questionnaire and the Developmental Tasks for Kindergarten Readiness are discussed during parent-teacher conferences and are used to develop classroom plans.



# THE PROGRAMS: EMERGENCY SERVICES

## Family dinner, on the table because of you.

Our Emergency Services Program accomplished a significant amount for our at-risk neighbors in 2012:

- 787 families fed -> three-day emergency supplies of food
- 517 families clothed -> vouchers to Opportunity House for clothing and household items
- 61 families secure -> intervention with rent and utility assistance to prevent eviction or utility shut-off
- 10,225 items distributed -> assistance with cleaning and hygiene products to ensure families are clean and cared for

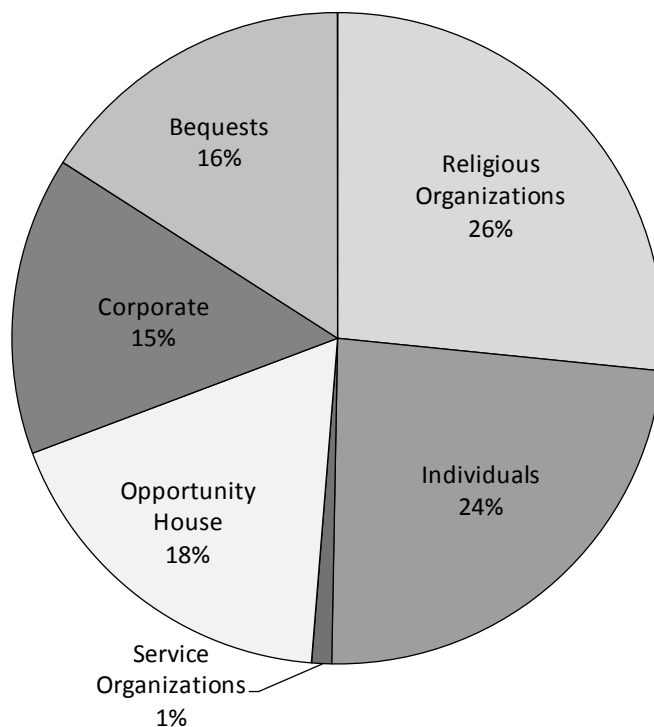
